## Commending the Trailblazers of FM Advancement.

**Details of the awards are listed below.**

## YOUNG ACHIEVER OF THE YEAR

Recognises an exceptional Facilities Manager under the age of 35 who is actively engaged in the FM industry and has demonstrated outstanding professionalism. This individual is passionate and driven by customer service, a role model, and have achieved notable successes in their career. They should also be making a personal impact in various aspects of the FM industry.

## FACILITIES MANAGER OF THE YEAR

The "Facilities Manager of the Year" award acknowledges an individual for their exceptional professionalism and significant contribution to the FM industry. The winner will be actively engaged in FM, passionate and driven to deliver top-notch customer service. They should be a role model and have achieved significant accomplishments in their career, as well as making a personal impact in various aspects of the FM industry.

## TECHNOLOGY IMPLEMENTATION OF THE YEAR

The "Technology Implementation of the Year" award will be given to the company that has effectively and successfully integrated technology into its infrastructure and core services. The winner will be selected from companies that have used technology to streamline and enhance their current service offering, reduced costs through sustainability, and introduced innovative and groundbreaking solutions to their clients or their corporation in the past year.

## AWARD FOR EXCELLENCE IN FM

The "Award for Excellence in Facilities Management" acknowledges the efforts of individuals, teams, or corporates involved in FM, from researchers to facility operators, who have made a positive impact on the knowledge, practical application, and communication of strategies aimed at enhancing the workplace environment and sustainable performance of their facilities. This award intends to recognise the the "best of the best" in FM.

## CHAIRMAN'S AWARD

The "Chairman's Award" is a merit-based honor given to individuals who serve as exemplary models and support the FM industry. This award is not given annually and is awarded when a deserving candidate has been identified through nominations from the board or members of the industry. The award recognises those who have made significant and lasting contributions to the FM industry and community, such as individuals who have conducted groundbreaking research, training organisations that have developed or marketed special programs, or journalists who have covered FM-related issues.

## MANAGEMENT AND RESPONSE TO SA'S WATER CRISIS

The "Management and Response to South Africa's Water Crisis" award recognises efforts by individuals, teams, or corporates who have made a positive contribution to managing and mitigating the effects of South Africa's water crisis. The award will be given to those who have developed and implemented innovative solutions to address the challenges faced by the country's water services sector and have demonstrated exceptional leadership and management skills in response to the crisis.

- » SAFMA reserves the right to use the submitted materials for promotion of the awards.
- » You agree that your submission may be entered into the Global FM Awards for Excellence.
- » By submitting, you agree to have the information included in the presentation used and published on the SAFMA website.
- » The organisers will not be held responsible for payment of royalties or other charges for the use of the submitted materials.

# JUDGING

The judging panel will comprise of experienced individuals from the FM industry and all entries will be evaluated by a minimum of two impartial judges. Only one round of entries will be accepted and all entrants will be asked to provide supporting documentation for their entry which should be verifiable.

## THE WINNERS OF EACH CATEGORY WILL RECEIVE:

- » A winner's trophy and certificate
- » Free entry to the next SAFMA conference and exhibition
- » An opportunity to address SAFMA members at a networking or educational event.

**Please note:** We will announce the winners at the Gala Evening of this year's 4th Annual Africa FM International Conference, which will run from 20 - 22 October 2024. Additionally, three winners will be selected and entered into Global FM's Awards.

Excellence is measured both internally and against external benchmarks. Discuss how your level of excellence compares to past performance and similar organisations using comparative data.

## 3. Corporate Outcomes

Provide quantifiable measures that demonstrate the benefits of your FM excellence, including improved asset life cycle, better asset functionality, and financial and environmental improvement. (The benefits may be to your FM organisation, your organisation's core business and/or your clients.)

## 4. Leadership and Success in FM

Describe how your FM leaders delivered excellence and innovation through a combination of processes, products, services, behavioural change, and training.

## 5. Contribution to Facility Management Worldwide

Discuss how your FM accomplishments can be replicated in other areas and companies. Describe any initiatives you have taken to share your success and promote excellence in FM, including presentations and publications.
